

STEAMED CHICKPEA (CP-S)

Grits, Meal, Flour

Steamed Chickpea ingredients are produced from whole, cleaned, dehulled chickpeas. The process utilizes a combination of steaming and milling without the addition of any processing aids. The steaming process inactivates the enzymes, stabilizes the protein and oil, and results in a pleasant, neutral flavor. The steaming is a validated kill step.

In addition to being a highly functional ingredient, Steamed Chickpea ingredients contain all the natural protein, fiber and oil that is found in the whole chickpea. No chemicals or processing aids are used in the making of these ingredients.
